Exclusive to Farpointe Data's *Pyramid Series Proximity*® line and *Delta*® Contactless Smartcard Readers, MAXSecure may be used to increase the security of any data format, such as Wiegand and ABA Track II magnetic stripe. MAXSecure adds a unique, high-security smart card-like hand-shake between reader and card, providing positive authentication before any card data is transmitted from the reader to the access controller. This can be used to ensure that your credentials in the field are unique (no duplicates!) and that unauthorized parties will not be able to order duplicates of your credentials, much less read them. These attributes lead to greatly increasing the security of the system. To maintain security, MAXSecure credentials can only be programmed in the factory by Farpointe Data.
